Submitted bids will be opened electronically at 11:00 AM on **Friday, March 22, 2024**; and will be posted to the Vermont Agency of Transportation website. The time of receiving and opening bids may be postponed due to emergencies or unforeseen conditions.

LOCATION: ALONG I-91 FROM MM 0.00 TO MM 177.432, ALONG I-89 FROM MM 0.00 TO 130.256, ALONG I-93 FROM MM 0.00 TO MM 11.100, ALONG I-189 FROM MM 0.00 TO MM 1.490, AND ALONG US-4 DIVIDED HIGHWAY FROM MM 0.00 TO MM 18.82 (NY STATE LINE TO JCT US-7).

TYPE OF CONSTRUCTION: WORK TO BE PERFORMED UNDER THIS PROJECT INCLUDES NEW PAVEMENT MARKINGS INCLUDING EDGE LINES, LANE LINES, DASHED AND DOTTED ACCELERATION LANES, RAMP EDGE LINES, STOP BARS, LETTERS, SYMBOLS, CROSSWALKS AND OTHER HIGHWAY RELATED ITEMS.
