

INVITATION FOR BIDS

Submitted bids will be opened electronically at 11:00 AM on **Friday, March 22, 2024**; and will be posted to the Vermont Agency of Transportation website. The time of receiving and opening bids may be postponed due to emergencies or unforeseen conditions.

LOCATION: STATE ROADS, CLASS 1 AND CLASS 2 TOWN HIGHWAYS WITHIN THE SOUTH REGION (DISTRICT #1, DISTRICT #2, and DISTRICT #3).

TYPE OF CONSTRUCTION: APPLICATION OF PAVEMENT MARKINGS WITHIN THE SOUTH REGION (DISTRICT #1, DISTRICT #2, AND DISTRICT #3). MARKING ON NATIONAL HIGHWAY AND STATE SYSTEM ROADS INCLUDES LONGITUDINAL LINES AND SELECT STENCILED MARKINGS, GREEN MARKINGS AND OTHER PAVEMENT MARKINGS. MARKING ON CLASS 1 AND CLASS 2 TOWN HIGHWAYS INCLUDES CENTER LINE PAVEMENT MARKINGS.

CONTRACT COMPLETION DATE: This Contract shall be completed on or before **October 11, 2024**.

BID BOND: Electronic bid bond to be submitted in the amount of 5% of the Contractor's bid.

ENGINEER'S ESTIMATE: For this proposal the Engineer's Estimate is **Category D**.
