ADDITIONAL BID INFORMATION:

LOCATION: THE PROJECT BEGINS AT THE INTERSECTION OF SEYMOUR ROAD IN SAINT ALBANS TOWN AND EXTENDS EASTERLY 26.01 MILES TO TROY STREET IN RICHFORD

TYPE OF CONSTRUCTION: WORK TO BE PERFORMED UNDER THIS PROJECT INCLUDES REHABILITATION OF TRAIL SURFACE AND IMPROVEMENTS TO ROADWAY CROSSINGS. ALL PROPOSED CONSTRUCTION TASKS ARE INTENDED TO BE CONFINED WITHIN THE EXISTING RAIL OR ADJACENT ROADWAY EMBANKMENTS.

CONTRACT COMPLETION DATE: This Contract shall be completed on or before **October 15, 2025**.

BID BOND: Electronic bid bond to be submitted in the amount of 5% of the Contractor's bid.
