TYPE OF CONSTRUCTION: REMOVAL AND REPLACEMENT OF BRIDGE NO. 6 WITH RELATED APPROACH ROADWAY AND CHANNEL WORK.

CONTRACT COMPLETION DATE: This Contract shall be completed on or before **October 16, 2026**.

BID BOND: Electronic bid bond to be submitted in the amount of 5% of the Contractor's bid.
