

INVITATION FOR BIDS

Submitted bids will be opened electronically at 11:00 AM on **Friday, July 11, 2025**; and will be posted to the Vermont Agency of Transportation website. The time of receiving and opening bids may be postponed due to emergencies or unforeseen conditions.

ADDITIONAL BID INFORMATION:

LOCATION: On VT Route 114 in the Town of Norton approximately 1.8 miles south of the international United States/Canadian border.

TYPE OF CONSTRUCTION: Removal of existing culvert, and replacement with a new open bottom buried structure.

CONTRACT COMPLETION DATE: This Contract shall be completed on or before **October 16, 2026**.

BID BOND: Electronic bid bond to be submitted in the amount of 5% of the Contractor's bid.

ENGINEER'S ESTIMATE: For this proposal the Engineer's Estimate is **Category D**.
