Submitted bids will be opened electronically at 11:00 AM on **Friday, January 30, 2026**; and will be posted to the Vermont Agency of Transportation website. The time of receiving and opening bids may be postponed due to emergencies or unforeseen conditions.

LOCATION: LOCATED IN THE TOWN OF BROOKFIELD, ON INTERSTATE 89 APPROXIMATELY 4.31 MILES NORTH OF THE RANDOLPH/BROOKFIELD TOWN LINE EXTENDING NORTHERLY APPROXIMATELY 215 FEET.

TYPE OF CONSTRUCTION: WORK TO BE PERFORMED UNDER THIS PROJECT INCLUDES THE REPLACEMENT OF THE EXISTING DECKS INCLUDING RELATED APPROACH WORK.

CONTRACT COMPLETION DATE: This Contract shall be completed on or before **October 15, 2027**.

BID BOND: Electronic bid bond to be submitted in the amount of 5% of the Contractor's bid.
