Award of Contract - It is the intent of the Vermont Agency of Transportation to award the contract pursuant to an acceptable and responsible low bid. The award of a contract is contingent upon FAA grant funding. If the contract is to be awarded, it shall be made no later than September 30, 2026, unless otherwise specified herein.

TYPE OF CONSTRUCTION: WORK TO BE PERFORMED UNDER THIS PROJECT INCLUDES CRACK SEALING EXISTING PAVEMENTS AND IN-KIND AIRPORT PAVEMENT MARKINGS
