

### INVITATION FOR BIDS

Submitted bids will be opened electronically at 11:00 AM on **Friday, June 19, 2026**; and will be posted to the Vermont Agency of Transportation website. The time of receiving and opening bids may be postponed due to emergencies or unforeseen conditions.

**LOCATION:** BEGINNING ON VT ROUTE 30 IN THE TOWN OF RUPERT AT MM 0.027 AND EXTENDING NORTHERLY ALONG VT ROUTE 30 FOR A DISTANCE OF APPROXIMATELY 11.601 MILES (61,253.28 FT) TO MM 7.800 IN THE TOWN OF PAWLET.

**TYPE OF CONSTRUCTION:** WORK TO BE PERFORMED UNDER THIS PROJECT INCLUDES FINE-MILLING AND RESURFACING THE EXISTING HIGHWAY, PAVEMENT MARKINGS AND OTHER RELATED HIGHWAY ITEMS.

**CONTRACT COMPLETION DATE:** This Contract shall be completed on or before **October 16, 2026**.

**BID BOND:** Electronic bid bond to be submitted in the amount of 5% of the Contractor's bid.

**ENGINEER'S ESTIMATE:** For this proposal the Engineer's Estimate is **Category E**.
