

INVITATION FOR BIDS

Submitted bids will be opened electronically at 11:00 AM on **Friday, July 10, 2026**; and will be posted to the Vermont Agency of Transportation website. The time of receiving and opening bids may be postponed due to emergencies or unforeseen conditions.

LOCATION: THE PROJECT BEGINS AT THE TERMINUS OF THE FEDERAL STREET EXTENSION SHARED-USE PATH IN ST. ALBANS CITY AND EXTENDS EASTERLY 0.506 MILES TO SEYMOUR ROAD (TH-105) IN ST. ALBANS TOWN.

TYPE OF CONSTRUCTION: WORK TO BE PERFORMED UNDER THIS PROJECT INCLUDES REHABILITATION OF TRAIL SURFACE, NEW TRAIL CONSTRUCTION, AND IMPROVEMENTS TO ROADWAY CROSSINGS

CONTRACT COMPLETION DATE: This Contract shall be completed on or before **May 31, 2027**.

BID BOND: Electronic bid bond to be submitted in the amount of 5% of the Contractor's bid.

ENGINEER's ESTIMATE: For this proposal the Engineer's Estimate is **Category D**.
