Submitted bids will be opened electronically at 11:00 AM on **Friday, September 18, 2026**; and will be posted to the Vermont Agency of Transportation website. The time of receiving and opening bids may be postponed due to emergencies or unforeseen conditions.

LOCATION: LOCATED ON ROUTE VT 110 APPROXIMATELY 3.5 MILES NORTH OF THE TOWN OF CHELSEA.

TYPE OF CONSTRUCTION: REPLACEMENT OF BRIDGE #13 ON VT 110 IN CHELSEA ON A SHIFTED ALIGNMENT WITH ROADWAY APPROACH WORK.

CONTRACT COMPLETION DATE: This Contract shall be completed on or before **June 15, 2028**.

BID BOND: Electronic bid bond to be submitted in the amount of 5% of the Contractor's bid.

ENGINEER's ESTIMATE: For this proposal the Engineer's Estimate is **Category E**.
